# AIBS 2024 Conference to Take a Critical Look at the Country's Socio-Political Developments

The "Bangladesh Conference 2024: Critical Perspectives," organized by the AIBS in collaboration with the South Asia Institute at the University of Texas at Austin, is set to take place on April 18–19, 2024, at the University of Texas at Austin. The two-day-long conference will host two plenary sessions and 14 panel discussions. More than 50 scholars will attend this in-person conference from around the world.

### AIBS Fellow's Scholarly Activities

#### AIBS Fellow Sharif Wahab Shares Insights on Rohingya Refugee Crisis at the University of Dhaka

Sharif Wahab, a 2023 AIBS Fellow and Ph.D. candidate from Indiana University Bloomington's Department of Geography, held an engaging session at the University of Dhaka's Institute of Social Welfare and Research (ISWR) on how Cox's Bazar City, Kutupalong refugee camp, and Bhasan Char Island are governing the lives of Rohingya refugees in Bangladesh. His presentation, stemming from his AIBS-funded dissertation fieldwork, offered insightful revelations about the governance of Rohingya refugees' lives in Cox's Bazar City, Kutupalong refugee camp, and Bhasan Char Island in Bangladesh.

Sharif's fieldwork, which combines ethnographic and archival research, sheds light on the political, social, and ecological challenges faced by the host community in Cox's Bazar following the significant influx of Rohingya refugees in 2017. He emphasized the importance of historical context in understanding the geopolitical complexities surrounding the Rohingyas' struggle for citizenship, repatriation efforts, and cross-border human rights issues.

#### Bushra Nayeem Explores Inclusive Housing Strategies at McGill University Symposium

Bushra Nayeem, AIBS Fellow (2022), shared her expertise at the McGill University symposium on the Minimum Cost Housing Group in Montreal, Quebec. AIBS has announced its annual fellowships for Bangladeshi citizens:

#### i. AIBS Bangladeshi Graduate Student Fellowship

The American Institute of Bangladesh Studies (AIBS) has recently announced research fellowships for Bangladeshi graduate students studying in the U.S. for the academic year 2023-2024. These fellowships aim to support Ph.D. and Master's students in meeting expenses related to scholarly research and creative projects in Bangladesh.

The application deadline is set for Sunday, March 10, 2024, at 11:59 pm U.S. Eastern Time. Eligible applicants include Bangladeshi citizens who are currently enrolled in Ph.D., MA, MS, or MFA programs at U.S.-based institutions. Research projects from a broad range of disciplines, including Humanities and Sciences, Social Sciences, Education and Public Health, Music and Fine Arts, Social Policies and Management, and other relevant fields, are encouraged.

#### Parvez Rahaman Explores Suhrawardy and Gandhi's Alliance Post-Noakhali Riots at South Asian Conference


AIBS Fellow Parvez Rahaman (2024) presented his dissertation chapter titled "Suhrawardy Joining Hands with Gandhi after the Noakhali Riots in 1946" at the 2023 South Asian Conference in Madison. Rahaman's research offers a nuanced exploration of the complex relationship between Huseyn Shaheed Suhrawardy, the then Muslim League leader and Chief Minister of Bengal, and Mahatma Gandhi in the aftermath of the Noakhali riots in 1946. Rahaman's paper delves into how Suhrawardy, influenced by Gandhi's philosophies, sought to restore confidence among the minority communities in divided Bengal and foster amicable Hindu-Muslim relations. Rahman's study contributes to a deeper understanding of the historical dynamics between these two prominent South Asian leaders and their impact on Hindu-Muslim unity in the region.

#### Melia Belli Bose Highlights Gender, Labor, and Textiles in South Asian Art

AIBS Fellow Melia Belli Bose (2023) has edited a special edition of the journal South Asian History and Culture, focusing on gender, labor, and textiles/fashion in South Asia. In this edition, Bose's article, "Uncomfortable quilts: textile-based artivism in response to Bangladeshi garment factory disasters," examines the response of four



visual artists to the tragic garment factory disasters in Dhaka, Bangladesh. Her essay examines how these artists use their work to highlight the human cost of 'fast fashion', addressing themes of globalization, gendered labor exploitation, and the importance of empathy.

Melia Bose has also published a book chapter titled, "The Razor's Edge: Gender Politics and Structural Violence in the Work of Bangladeshi Artist Tayeba Begum Lipi." This chapter is part of the collection Women across Asian Art: Selected Essays in Art and Material Culture, edited by Ling-en Lu and Allysa B. Peyton and published by the University Press of Florida. In this insightful chapter, Melia Bose explores the intersection of gender politics and

structural violence in Tayeba Begum Lipi's artwork, offering an insightful analysis of contemporary art in South Asia.

To be considered for this fellowship, graduate students should be in the advanced stages of their programs. Those who have previously applied for the fellowship but did not receive an award are welcome to reapply.

The maximum award amount is \$3,000, and the funds must be utilized before September 30, 2025. Recipients are required to report to the AIBS Dhaka office in Bangladesh and plan a research outreach event with an AIBS partner university at the end of their research trip. The fellowship will cover expenses related to the research project in Bangladesh.

Applications will be evaluated based on the project's impact, significance, innovative approach, and feasibility. A crucial component of the application is a letter of recommendation from the student's faculty advisor, discussing the project's feasibility and contribution to the student's academic progress.

#### ii. AIBS Professional Development Fellowships for Bangladeshi Scholars

AIBS has also announced the new round of Professional Development Fellowship for Bangladeshi scholars. This program offers a unique opportunity for scholars working at AIBS partner universities in Bangladesh to collaborate with U.S. faculty members, enhance their research skills, and gain experience in academic writing and publication.

Applications are open until Sunday, March 10, 2024, at 11:59 pm U.S. Eastern Time. Eligible candidates include Bangladeshi citizens currently employed at one of the AIBS partner universities in Bangladesh. A key requirement for the application is a letter of invitation from a U.S. faculty member.

The fellowship, ranging from \$4,000 to \$5,000, is designed for a six-week duration and must be utilized before September 30, 2025. It will cover professional development expenses such as travel, lodging, food, and educational materials.

To apply, applicants must submit an online form detailing their goals, outcomes, and timeline for the visit (max 500 words), a recent CV, and a letter of invitation outlining additional campus resources and plans for a public event showcasing the scholar's work.

## Rabiul Islam's Study Sheds Light on the Socio-Economic Impact of Foreign Remittances in Rural Bangladesh

AIBS Fellow Rabiul Islam's (2022) has completed a study on the critical influence of foreign remittances in transforming the socio-economic landscape for families of international migrant workers in rural Bangladesh. The research, focusing on workers in Malaysia, explores the utilization of remittances and the various channels families use, including land transactions and loans, to finance migration. The study highlights the risks faced by workers, including exploitation by unscrupulous agents.

## Kajalie Shehreen Islam Explored Bangladeshi Youth Engagement in Social Media

AIBS Fellow Kajalie Shehreen Islam (2022) has recently published her paper titled "Gendered Political Communication: A Study of the Coverage of Women Politicians in the Bangladeshi Press," in the Social Science Review (vol.39, issue. 3)). Kajalie Islam probes into the gendered portrayal of female politicians in Bangladeshi media. Utilizing framing and discourse analysis, along with interviews of women Members of Parliament, her paper reveals how women politicians are often framed in relation to male mentors and perceived as inexperienced or only representative of women voters.

Kajalie Islam also presented a paper at the "International Association for Media and Communication Research (IAMCR) 2023" conference held at the University of Lyon in July 2023. Titled "The Rohingya Conflict in the Media: Discourses and silences around sexual violence," her work critically examines the media coverage of sexual violence against the Rohingyas across Burmese, Bangladeshi, and US media. The paper's discourse analysis offers insights into how the media frames victims-survivors of sexual violence in conflict, exploring its implications for international politics and justice.

#### Md Muhibbur Rahman published in Foreign Policy Analysis

AIBS Fellow Md Muhibbur Rahman (2022) has published an article titled "The Political Economy of Peacekeeping: Civil–Military Resource Substitution through International Brokerage," at Foreign Policy Analysis. Muhibbur's two other papers have been accepted for presentation at the International Studies Association (ISA) and the Midwest Political Science Association (MPSA) in 2024.

#### Mohammad Tareq Hasan Explores Labor Rights and Dispossession in Bangladeshi Garment Factories

AIBS Fellow Mohammad Tareq Hasan (2024) has published a chapter titled "Moral Jeopardies and Exorcisms in the Global Production Network: Auditing, CSR, and 'New' Dispossession in a Bangladeshi Garment Factory" in the edited volume Morality as Organizational Practice: Negotiating, Performing, and Navigating Moral Standards in Contexts of Work. The chapter focuses on the aftermath of tragic accidents in the garment industry, highlighting the implementation of factory compliance principles driven by global buyers' ethical labor codes. Hasan critically examines these initiatives, often labeled as 'exorcisms' for humane capitalism, and their interplay with factory auditing, Corporate Social Responsibility (CSR), and labor laws.

He argues that while these measures serve capital accumulation and promise long-term growth, they exacerbate the existing crisis and intensify dispossession against workers. The volume is edited by Sarah May, Stefan Groth, and Johannes Müske, and published by Waxmann Verlag GmbH.

## Shanawez Hossain sheds light on integrating Inclusivity in urban planning to achieve the SDGs

Md Shanawez Hossain, Assistant Professor of Global Studies & Governance at Independent University, Bangladesh, and an AIBS Professional Development Fellow (2023), delivered a keynote address at an event organized by the Citizen's Platform for SDGs, Bangladesh. The event, held on October 18, 2023, at the Brac Center, Dhaka, focused on "The citizen's agenda for inclusive development and fairness." Hossain's presentation, titled "Providing public utilities and services in the backdrop of unplanned urbanization," highlighted the challenges posed by unplanned urbanization in Bangladesh.

In his address, Hossain shed light on the substantial investments in urban development over the last decade but pointed out their lack of inclusivity, safety, and resilience. He emphasized the diminished quality of life in Bangladeshi cities, referencing global indicators that rank them among the least livable. Hossain advocated for a shift from ad-hoc solutions to comprehensive master planning, underscoring the need to strengthen local government institutions, amend laws and policies, and ensure the integration of Sustainable Development Goals (SDGs) into urban planning.

#### Marshall Azad Examines Elder Care and Domestic Servitude Dynamics in Recent Feminist Studies Publication

Marshall Azad, a former AIBS Bangla Language Fellow, has published a thought-provoking paper in Feminist Studies' special issue on autotheory. Titled "Serving the Aging: Navigating Elder Care, Domestic Servitude, and Crisis in a Home Away from Home," the article, featured in the December 2023 issue, explores the complex dynamics of elder care and domestic servitude in Dhaka. Through a personal narrative, Azad examines the unsustainable workload of domestic workers, the undervaluation of their labor, and its link to the broader global care crisis. The paper urges the Bangladeshi middle class to reconsider their dependence on domestic labor for care needs, highlighting a critical moment for societal introspection.
